DIRECTIONS:

PORTABLE TOILETS: For summer use, add 8 to 12 ounces of **TOILET D-ODOR** per 60 gallons of toilet capacity. During winter or colder periods, use 3 to 6 ounces per 60 gallons of toilet capacity.

MARINE AND RV TOILETS: Add 16 ounces with sufficient water to cover the bottom of holding tank.

Note: Very warm weather, long time periods between pump-out, or heavy loading may require more treatment to adequately control odors. This product should not be used in septic systems or permanent pit toilets, as it will prevent bacterial digestion of wastes. Treated waste should be disposed of through municipal treatment plants - do not apply to farmland.
